









# September 9-10, 2023 Fishing Tournament Rules and Information

#### About the tournament

Ta'ape (*Lutjanus kasmira*) were first introduced by the Hawai'i Territorial Government in the 1950's from French Polynesia to supplement Hawaii's local fisheries. While ta'ape was one of dozens of species introduced to Hawai'i, none of the other species have attained such numbers in the ensuing decades. Ta'ape can now be found in large schools throughout the entire Hawaiian archipelago and are found in shallow waters to depths of over 400 ft deep. Due to their smaller size (generally less than 12 inches) and yellow color, their market value has always been lower than comparable fish. Despite this, ta'ape are an excellent food fish and are growing in popularity with chefs and sustainability-minded fishers. The Division of Aquatic Resources (DAR) is holding this tournament to promote ta'ape as a delicious, abundant, and sustainable food resource. DAR is excited to feature Chef Mark Oyama of Mark's Place Restaurant and Contemporary Flavors Cuisine who will be hosting a fish fry at the tournament weigh-in.

This tournament is funded in part by the Sport Fish Restoration Act federal grant funds and contributes to the statewide efforts of The Ta'ape Project, which aims to promote ta'ape with local fishers, chefs, and businesses and is run by local nonprofits Chef Hui and Conservation International Hawai'i.

#### Tournament dates (all eligible fish MUST be caught during the following times)

Tournament start: Saturday, September 9, 2023 at 6:00am.

Tournament stop: Sunday, September 10, 2023 at 11:00am.

All teams must notify tournament organizer (Aaron Swink 808-271-0089) via text when they begin fishing and when they stop.

## Weigh-in:

September 10, 2023 from 11am-12pm at the Kauai Sailing Association building (formerly Nawiliwili Yacht Club). Nawiliwili Small Boat Harbor, 2494 Waapa Rd, Lihue.

If fishers want to weigh-in fish, you must be in the weigh-in line before 12:00pm to be eligible for prizes. Fish must be in good shape (not mutilated, damaged, or spoiled) and kept on ice.

Fish fry with Chef Mark Oyama and prize ceremony from 12-1pm at the Kauai Sailing Association building.

This is a "catch and cook" tournament. Teams may donate their catch after weigh-in to be cooked up by Chef Mark and enjoyed by tournament participants.

### Fishing tournament boundaries:

Any state waters (up to 3 miles out) around Kauai not prohibited to fishing pursuant to Hawaii Administrative Rules, Title 13, Subtitle 4.

## Fishing methods:

Any legal method of fishing in areas not prohibited to fishing pursuant to Hawaii Administrative Rules, Title 13, Subtitle 4. ## **Eligible species**

Ta'ape – Blueline snapper, Lutjanus kasmira

To'au - Blacktail snapper, Lutjanus fulvus

#### **Teams**

Teams must have a minimum of 2 fishers (for safety reasons) and a maximum of 6 fishers.

## Winning categories:

- Highest cumulative weight (top three teams all eligible species combined weight)
- Heaviest fish (individual winners, ta'ape only)
  - Heaviest fish overall
  - Heaviest fish caught by a youth under 10
  - Heaviest fish caught by a youth ages 10-13
  - Heaviest fish caught by a youth ages 14-17

Each fisher may select only one fish from their catch to submit to the weighmaster to compete for the heaviest fish category. In the event of a tie, the fish with the longest fork length will win the tie-breaker.

## **Eligibility:**

All tournament participants must submit a completed entry form, signed waiver, and release form by the registration deadline 12:00pm Friday, September 8<sup>th</sup>, 2023.

Minors must have parental/guardian consent.

All fish entered for weigh-ins must be fresh. No spoiled, rotten, or mutilated fish will be accepted.

## **Disqualification:**

Any violations to the tournament rules or fishing regulations (HAR 13-4), Federal, State or County laws, unsportsmanlike conduct including the disrupting or harassing of other participants, fishing outside of the tournament boundaries, entering fish for weigh-in caught before the tournament begins, or any other matters brought to the tournament staff's attention that are deemed unsportsmanlike, will be grounds for immediate disqualification from the tournament and any eligibility of winning prizes.

#### **Protests:**

Any protests need to be announced verbally to the tournament staff at the time of the incident, at the designated weigh-in date and time listed above.
